EOH Assembly Mission Statement: To reduce the Burden of Respiratory Illness from Environmental and Occupational Exposures through Research, Patient Care and Education.

Welcome to the spring newsletter. It has been a very interesting experience to Chair this Assembly since last May, and to learn more about the activities of the Assembly and the ATS Board of Directors. It has made me appreciate more than ever the effectiveness and seemingly effortless work of David Tollerud as previous Assembly Chair who led the Assembly into the current vibrant form. Our Assembly owes thanks to him for his leadership in the previous two years.

Currently our Assembly has 499 primary members (1337 primary and secondary members) of whom about one third are from outside of North America. In recognition of the importance of the international nature of our membership we have formed a new EOH Committee, the International Committee, which Bill Beckett has agreed to chair. This builds on our previous Assembly practice of having an **EOH** International leadership lunch each year at ATS.

The other new committee, which involves our Assembly as a major contributor is the ATS Environmental Health Policy Committee. This is an ATS Committee rather than an Assembly Committee but the Chair, Bill Rom, and several of the members (Isabelle Romieu, Kent Pinkerton, Mark Frampton and Jon Samet) are primary members of our Assembly. I have therefore asked Bill to provide a short report for this newsletter since clearly the issue of air pollution is central to our Assembly.

Further important reports in this newsletter are from the Planning Committee, very actively and ably chaired by Carrie Redlich, and the Program Committee chaired by Kent Pinkerton, which has led to an outstanding program this year. Both Committees perform crucial roles in our Assembly and require dedication and

Our new website editor is Sushma Bhat, and with initial help from Akshay Sood, she has enthusiastically taken on this role and has increased and updated the web-site information. I would again encourage those of you with interesting cases to submit them for website publication (which is associated with a citable reference), and which has been a popular site for residents and fellows and may encourage more interest in occupational and environmental lung disease. Formal instructions for submissions can be found on the website. If you have digital images of pneumoconiosis cases to add to the website, Sushma would also be pleased to receive these. In addition, since Sushma will have increased commitments in the coming year, I would encourage anyone with interest in helping Sushma with the website

to contact her or myself.

In further news, the Bioterrorism Section, previously Chaired by Mark Frampton is now re-named the section on Terrorism and Inhalation Disasters. It has broad ATS participation but is "housed" in EOH. Rogene Henderson and Charles Frevert are the current Co-Chairs, with the new Co-chair for next vear Chris Lettieri. They are encouraging submissions for Annual Meeting, have a postgraduate course approved, and are in a process of developing a web-page. Their focus is broader than bioterrorism and includes disasters, large scale emergencies, and

emerging threats. Members from our Assembly have also provided assistance to ATS in relation to other environmental and occupational questions, and have provided input to the Research Advocacy Committee regarding the NIEHS strategic plan.

As we move towards a new Assembly year, I look forward to more exciting developments. I'd be very happy to hear suggestions from any members of our Assembly. We hope to attract more young colleagues, so please bring them to our Assembly Meeting at ATS, and I look forward to seeing you there.

The past year was an active one for EOH Assembly Projects, with several completed, ongoing, and newly funded projects:

Completed Projects: 1) **2nd Jack Pepys Workshop on Occupational Asthma** (Project Chairs - Susan M Tarlo and Jean-Luc Malo). A

(Continued from page 2) document summarizing this workshop, which was held in May 2004, is published in the European Respiratory Journal - An ATS/ERS Report: 100 key questions and needs in occupational asthma (ERS 2006; Vol 27(3). The slides from the workshop are on the website of the Center for Asthma in the Workplace (www.asthmaworkplace.com), listed under the 2004 events.

Projects in Progress: 1) Revision of ATS/ DLD Questionnaire

(Project Chair - George O'Connor) The revised Respiratory Disease Questionnaire - Adult Version is undergoing a second round of cognitive evaluation at the National Center for Health Statistics, as well as field-testing by Susan Kennedy in Vancouver. Dr O'Connor plans to have a final version available by the 2006 ATS Annual Meeting. As the Adult Version is close to finalized, the committee plans to turn its attention back to the development of a revised a Childhood Version.

2) ATS Statement on Health Effects of Tremolite (Project Chair - Marc Schenker) The final Tremolite

document is in preparation. The committee hopes to have it submitted to the ATS Board by the 2006 ATS Annual Meeting. The topic continues to be one of importance in the U.S. and elsewhere in the world as government agencies and the public grapples with how to respond to nonoccupational asbestos deposits.

3) **Stress and Asthma Workshop** (Project Chair - Rosalind Wright)

A document summarizing this workshop, which was held in October 2004, with funding from ATS as well as NHLBI and the Fetzer Foundation, is nearing completion. The focus of the publication, to be submitted to AJRCCM, is the methodology involved in measuring stress, and research gaps relevant to asthma and lung diseases in general.

4) Standardizing Low Molecular Weight

(LWM) Occupational Allergens (Project Chair - Adam Wisnewski). A workshop was in conjunction with the ATS 2005 conference, with support from the ATS. Over twenty participants with expertise in immunology, biochemistry, and clinical occupational asthma met to identify key issues, including theoretical and technical aspects of the problem. Additional funding was requested and approved by the ATS for the current year to complete a manuscript focused on the workshop proceedings; providing guidelines and recommendations for the preparation and use LMW occupational allergens. A brief working meeting is planned at ATS 2006 to further develop this document.

Newly Funded Projects:

Work-Exacerbated
Asthma (Project Chair
Paul Henneberger)

Paul Henneberger recently received ATS funding to conduct a workshop and prepare a statement on Work-Exacerbated Asthma. A preliminary meeting was already conducted in December 2005 in Arlington, Virginia, supported by the National Institute for Occupational Safety and Health, Centers for Disease Control and Prevention (NIOSH/ CDC). The workshop will take place in conjunction with the 2006 ATS Conference. 2) Biomass Combustion and Respiratory Health (Project Chair -Isabelle Romieu) Isabelle Romieu received ATS funding to convene a Biomass Combustion Working Group and hold a workshop focusing on the health impacts of exposure to smoke from combustion of wood and other bio-

(Continued from page 3) mass and explore future research agendas. A subsequent state-ofthe-art review or ATS statement on biomass combustion and respiratory health is planned. If interested in more information please contact Isabelle Romieu at email address iromieu@correo.insp.mx.

Carrie A. Redlich MD, MPH will continue as Program Chair of the EOH planning Committee for the coming year. EOH members are encouraged to submit applications for Assembly / Committee projects, which can span a range of EOH issues, problems, or activities relevant to the EOH assembly, the larger ATS membership, or to investigators and health practitioners outside the ATS. Project applications, which are not lengthy, are usually due mid-July. Funding odds appear to be much better than NIH proposals.

EOH Program Committee

The 2006 ATS International Conference will showcase over 300 abstracts from our assembly presented over 4 days in 5 symposia, 5 mini-symposia, 5 poster discussions and 5 thematic poster sessions. Exciting presentations are scheduled from more than a dozen countries. Cochairs and facilitators from our assembly will provide an exciting program to stimulate lively interactions and discussions among the participants. The EOH assembly will also sponsor a postgraduate course on emergency responses to natural disasters as well as acts of terrorism as part of the educational meetings offered before the official opening of the 2006 conference. The program for this year is truly a stellar year for the presentation of original research, studies and cutting edge concepts in environmental and occupational medicine. Please be sure to attend by searching for EOHsponsored sessions at this year's meeting!

ATS International Lung Health Committee Bill Beckett, MD

The International Lung Health Committee of ATS has among its charges to facilitate interactions of the ATS with all non-US organizations and with international programs of organizations within the US. Another objective is to develop strategies to enable ATS to be more effective in promoting lung health throughout the world. Ongoing activities include support of international STOP TB activities, and support of the annual international epidemiology MECOR course, recently described by ATS President Peter Wagner in the ATS News.

New initiatives include support for an organizational meeting of the newly established Pan African Thoracic Society. Drs. Stephen Gordon of UK and Heather Zar of South Africa described plans for an inaugural in organizational meeting of African pulmonologists to be held in Cape Town.

The European Respiratory Society has also recently joined in financial support of this effort. This committee

(Continued from page 4) has also supported establishment of an ongoing Trainee International Travel Award Program to bring young investigators from other countries to the ATS in a format that will support their professional development and help them establish research col-

laborations with ATS investigators. This program was conceived by Dr. Gustavo Matute-Bello of the University of Washington. One goal of this committee is for each ATS Assembly to establish its own International committee to encourage and support international

members as assembly leaders. EOH Assembly Chair Dr. Susan Tarlo asked Bill Beckett to establish this committee for the EOH Assembly, and he will be joined by Dr. Wan-Chen Tan, of the National Singapore University and University of British Columbia, Vancouver. She was nominated for this position by the Asia Pacific Respiratory Society.

The agenda for this new committee has been a focus on outdoor air pollution and the EPA, in particular. The committee has been closely monitoring and participating in the EPA standard setting process for particulate matter (PM2.5) and ozone.

PM2.5

The committee has been very active in analyzing and responding to EPA documents regarding the standard for particulate matter. The Committee reviewed the EPA staff paper, a compendium of existing research on the health effects of particulate matter. The EPA staff paper provides analysis of the existing research on PM and made a recommendation that EPA consider issuing a standard that is more strict than the existing standard.

The Committee, on behalf of the ATS, has reviewed the EPA staff paper and provided both written and oral comment the EPA analysis. The ATS comments supported the overall conclusion of the EPA staff paper and recommended EPA consider setting the revised standard at the lower end of the range proposed by the EPA staff paper, specifically:

12 microgm/m3 for the average annual standard 25 microgm/m3 for the 24-hour standard, 99th percentile for data monitoring

The current standard is:

15 microgm/m3 for the average annual standard 65 microgm/m3 for the 24-hour standard 98 percentile for data monitoring

Additionally, the ATS sent a letter to the EPA Administrator urging the EPA to issue a revised PM rule of 12/25/99. The Am Coll of Cardiology, Am Coll of Prev Med, Am Public Health Assoc, and several respiratory care groups joined the ATS in the letter to the EPA Administrator. Committee member Dr. Dorr Dearborn had personal meeting with EPA Administrator Johnson to make the case for tightening the EPA standard for PM.

In December, EPA Administrator Johnson issued a proposed new standard for PM of: 15 microgm/m3 for the average annual standard 35 microgm/m3 for the 24-hour standard 98 percentile for data monitoring

The proposed standard largely ignores the recommendations of the ATS, the Clean Air Scientific Advisory Committee and the EPA, all of whom recommended a more stringent standard. The public comment period for the proposed PM rule ends April 17th.

In response to the Administrator Johnson's proposal, Drs. Rom and Samet have a commentary in press with the Am J Respir Crit Care Med criticizing this standard. The committee will also coordinate ATS involvement in local field hearing on the PM rule in Chicago, Philadelphia and San Francisco expected in February. The committee will draft comments on the proposed rule for ATS leadership review.

OZONE

The committee has also been active in the rule making process for ozone. The EPA has just begun the process of collecting and interpreting existing research on the health effects of ozone and has released an initial draft EPA staff paper. The EPA staff paper also calls for a tightening of ozone standard. Committee member Richard Dey MD provided comment to the EPA on the draft staff paper. Several iterations of the EPA staff paper are expected over the next year. The committee will continue to review and provide comment on future EPA drafts. EPA is expected to issue a proposed rule on ozone in December 2006.

Section on Terrorism and Inhalation Disasters Charles Frevert, MD

Between the sarin attack in Tokyo, Sept 11th, the anthrax scare of 2001, the tsunami in 2004, and the Gulf Coast hurricanes this past year, one is reminded that disasters occur and are not uncommon. In the November 2005 ATS News, Peter Wagner, M.D. discussed the role of ATS in response to disasters and laid out a clear path for the society to follow. He also charged the Section on Terrorism and Inhalation Disasters (TID) of

the Assembly on Environmental and Occupational Health to formulate a proposal to address how ATS can respond to future disasters.

In their proposal the TID section leaders developed goals in the areas of research, education, and clinical outreach to allow ATS to respond to both natural and man made disasters. Key to this proposal is the need to develop strategies for clinical outreach. This is an area that Christopher Lettieri, MD the section's co-chair elect has been working on over the past year. Short term strategies for clinical outreach include a Symposium and a Post-Graduate Course that will take place at the International Conference in San Diego in May 2006.

- ATS Symposium: The Pulmonary and Critical Care Response to Catastrophes
- ATS Post Graduate Course: Disaster Medicine: The Medical Response to Terrorism, Natural and Industrial Catastrophes. This course, which will be given on Saturday, May 20th requires Registration.

Long term strategies of this section include the development of a Disaster Medicine Network where collaborations with the appro-

The timeline for the application and review process follows:

April 2006: FY2007 forms are available

July 25, 2006: Assembly/Committee project applications are due to the ATS office. Late submissions will not be accepted.

Early-mid August 2006: abridged versions of the proposals will be posted on the ATS site and emails will be sent to ATS Leadership, Assembly Planning Committee Chairs, Assembly Chairs, ATS Committee Chairs, appropriate ATS staff and the PRS committee, to notify them that the current, un-reviewed proposals are available. This will give everyone an opportunity to touch base with any of the applicants if they would like to get involved with a project before it goes to the PRS for review.

August 1-18, 2006: Assembly Planning Committees will meet via conference call to review appropriate proposals. Any proposal that has indicated on the form that a specific ATS committee may want to become involved will be sent to the ATS committee chair and to the appropriate staff member. Committees are encouraged to work with appropriate ATS staff and review any proposals and to send recommendations to the applicant and to the PRS.

September 6, 2006: Revised proposals and all reviews from Assemblies and Committees are due to ATS office. This includes any proposal that has revisions based on a review by an Assembly Planning Committee or an ATS Committee.

Early October 2006: Program Review Sub-Committee (PRS) meeting.

Early November 2006: Program & Budget Committee (P&B) meeting. Recommendations from the PRS will be provided to the P&B Committee. At the discretion of the P&B Committee, specific projects will be added to the FY2007 budget as new items.

December 2006: ATS Board reviews FY 2007 Budget.
