Message from Assembly Chair

Welcome to the spring newsletter. As I come to the last few months of my term as Assembly Chair I would like to express my appreciation for having had the opportunity to hold this position. It has been a wonderful experience to interact with Assembly members, and particularly those on the various Assembly Committees. As you can see from the reports of the Chairs of these committees there is a lot of activity within our Assembly and I am sure that Kent Pinkerton as the incoming Assembly Chair will also have great support in

his term for the next two years, and will also find the associated membership on the ATS Board of Directors to be a fascinating experience.

Our Assembly has 512 primary members (1325 primary and secondary members) of whom about one third are from outside of North America. Bill Beckett Chairs the EOH International Committee and our Assembly continues to have strong international representation on our committees and as speakers at the Annual Meeting. In comparison to the other ATS Assemblies it is somewhat smaller than the average size in membership but has more than the average number of Assembly projects, both new and ongoing projects, attesting to the enthusiasm and commitment

of the members. Carrie Redlich as Planning Chair has encouraged submission of new projects and has been extremely well organized in leading her committee in the review of projects and provision of constructive suggestions to enable successful ATS support for many of the new and continuing proposals this year. She has graciously agreed to continue in this role for a further year, which will provide continuity over the change in Assembly Chair.

Lisa Maier as Chair of the EOH Assembly Program Committee (and Rebecca Bascom as chair-elect) have developed an outstanding EOH component to the ATS program this year as detailed later in the newsletter. George

I have been especially pleased to see that many of our Assembly Committees now include young members. We are also represented in an ATS wide symposia, "Outstanding Research Symposium/Scientific Breakthroughs of the Year" programmed on Sunday, May 20th. I would like to make special mention of an EOH Scientific Symposium "Air Pollution: From Science to Policy", scheduled on Tuesday May 22nd, which will commemorate David Bates. William Rom, MD, MPH will be providing a few words about David, who was an important member of our Assembly.

Believe it or not, we are now starting to get ready for ATS 2008, May 16 - 21 in Toronto. Rebecca (Becky) Bascom MD, MPH will be taking over the helm as Program Chair and is working on her new committee membership. We are requesting input from the Assembly and hope you have started to think about interesting topics and speakers for Postgraduate courses, Scientific Symposia, and Meet the Professor and Sunrise Seminars for ATS 2008. The ATS conference is a good time to finalize plans for sessions for next year, which are due in an online submission in June 2007 (date to be determined). We do expect to have a similar number of sessions available for next year. In addition, the ATS International Conference Committee

now programs 2 joint Scientific Symposia that are proposed by multiple Assemblies. If you have a topic that might be more appropriate for this mechanism, you may want to discuss this with Becky. In the past, the EOH Assembly has not proposed sessions for Clinical Workshops, although we may want to consider doing so in the future. These clinical sessions occur at noontime and might be a way to increase awareness of the clinical topics we represent and deal with.

We are hoping to see all of you at the ATS 2007 International Conference in San Francisco, from May 18-23.

The past year was an active one for the EOH Planning Committee

and EOH Assembly Projects. Nine proposals for EOH Assembly projects were submitted and reviewed by the EOH Planning Committee (8 proposals for new EOH Projects and 1 Renewal Project proposal). These projects were discussed and evaluated by the EOH Planning Committee via conference call (8/2007), and revised proposals were re-submitted for final review by the ATS. Four projects were

funded, one EOH renewal project (Work Exacerbated Asthma), and 3 new EOH As-

sembly Projects (see below). Projects that were not funded can be resubmitted. The ATS funded

a total of 8 new projects for all the Assemblies.

Projects in Progress:

1) ATS Statement on Health Effects of Tremolite (Project Chair - Marc Schenker). The final Tremolite document was submitted to the ATS board in 2006 and is under review.

2) Standardizing Low Molecular Weight (LWM) Occupational Allergens (Project Chair - Adam Wisniewski). The original workshop was held in conjunction with the ATS 2005 Conference, with a brief follow-up meeting at the ATS 2006 Conference. An ATS Workshop summary document is in progress and will be submitted to the ATS in 2007. This manuscript will summarize theoretical and

technical aspects regarding assays for LMW occupational allergens, and provide guidelines and recommendations for their preparation and use, including a section on resources and internet links.

3) Work-Exacerbated Asthma (Project Chair - Paul Henneberger). The goals of this ATS Project, which is supported by the ATS and the CDC/NIOSH, are to review and synthesize the literature on work-exacerbated asthma (WEA), including the nature and extent of the problem, and identify research and clinical needs, as well as increase awareness of WEA. A

workshop was held in conjunction with the ATS 2006 conference, and a follow-up working meeting was held in November 2006 to work on an ATS Public Policy Statement addressing these issues. Additional funding was requested and approved by the ATS for the current year to complete the ATS Policy Statement on WEA. A brief working meeting is planned at the 2007 ATS Conference to finalize this document. Newly Funded EOH Projects:

1) Diagnosis and Management of Beryllium Sensitization and Chronic Beryllium Disease (Project Chairs - John Balmes and Milton Rossman). This primary goal of this project, which is jointly supported by the ATS, the U.S. Department of Energy (DOE), and NIOSH, is to establish consensus among a panel of international experts regarding

criteria for the diagnosis, clinical evaluation, management and prevention of beryllium sensitization (BeS) and chronic beryllium disease (CBD). A consensus ATS Policy statement addressing these issues will be developed by the committee, which will meet in conjunction with the May ATS 2007 International Conference, as well as ad-

ditional conference calls to work on the ATS Policy statement.

2) 3rd Jack Pepys Workshop on Asthma in the Workplace (Project Chairs - Susan Tarlo and Jean-Luc Malo). The goal of this project is to hold a Third International Symposium on Asthma in the Workplace in Montreal,

May 2007, to review new developments, further identify research needs and build collaborations, with a focus on work-aggravated asthma, psychosocioeconomical aspects, prevention and management. This 3rd Jack Pepys Workshop is funded jointly by the ATS, the WSIB, CSST, IRSST, and CIHR. Further information on the Workshop can be obtained at www.asthma-workplace.com or by contacting Mrs. Sylvie Daigle at s-daigle@crhsc.rtss.qc.ca.

3) Novel risk factors and the global burden of non-smoking COPD (Project Chair – Mark Eisner). The goal of this project is to develop an ATS statement

that will evaluate the contribution of untraditional risk factors, other than smoking, to the development of COPD. Such environmental and host risk factors include environmental tobacco smoke, occupation, biomass fuel combustion, air pollution, long-standing asthma, and genetic and dietary factors. The committee, an international panel of experts in these areas, will systematically review and evaluate the relevant epidemiologic literature, and estimate or summarize the contribution of each of these risk factors to the development of COPD, where appropriate. An ATS statement based on this systematic review of the literature will be developed by the committee, which will have its

first face-to-face meeting in conjunction with the May ATS 2007 International Conference.

Carrie A. Redlich MD, MPH will continue as Chair of the EOH Planning Committee for the coming year. EOH members are encouraged to submit applications for Assembly / Committee projects, which can span a range of EOH issues, problems, or activities. If you have an idea for a project (or want to serve on the Planning Committee in the future) please contact Carrie Redlich (carrie.redlich@yale.edu) or other members of the Planning Committee. Project applications are usually due mid-July.

Update from the Section on Terrorism and Inhalation Disasters

Most people have short attention spans when it comes to being concerned about man-made or natural disasters. Despite transient attention to anthrax, SARS, tsunamis and hurricanes as well as the potential for a serious influenza pandemic, the public's concerns about future events rapidly wane due to the limited frequency and unpredictability of disasters. However, there are two certainties when it comes to disasters. First, the only thing that is predictable about disasters is that they will continue to occur. Second, because of its role in critical care medicine and biomedical research, ATS and its membership need to play an important role in the preparation for future disasters.

In order to play a more active role in disaster preparedness we are strengthening the leadership in the TID section by developing a more formal committee structure. This includes the development of a Planning Committee, which will have several responsibilities including an advisory role to ATS leadership on disaster related issues and the identification of future concerns about potential disasters that would be relevant to the ATS membership. In order to meet its responsibilities this committee will be made up of individuals with diverse clinical and research backgrounds including disaster preparedness, toxicology, aerosol biology, infectious disease, ethics, and policy.

If you are interested in disaster preparedness we would like to invite you to the annual membership meeting of the TID section during the international meeting in San Francisco. The business meeting will be held on Sunday, May 20th from 12 Noon – 1:30 p.m. at the Parc 55 Hotel, Park Ballroom II (Level 4).

Please consider submitting an Assembly/Committee Project Application for funding in FY2008!

For your information, the FY2008 (January 1-December 31, 2008) project application forms for Assembly/Committee projects will be available on the ATS website (www.thoracic.org) on May 1, 2007. There will be a link to the project submission forms on the ATS homepage. Please consider submitting an application for an Assembly/Committee project. If you have an idea for a project application and you need assistance, please contact your Assembly Planning Committee chair Carrie A. Redlich at carrie.redlich@yale.edu.

The timeline for the application and review process follows:

- ♦ May 2007: FY2008 forms are available
- ♦ July 23, 2007: Assembly/Committee project applications are due to the ATS office. Late submissions will not be accepted.
- ♦ Early-mid August 2007: abridged versions of the pro-

posals will be posted on the ATS site and emails will be sent to ATS Leadership, Assembly Planning Committee Chairs, Assembly Chairs, ATS Committee Chairs, appropriate ATS staff and the PRS committee, to notify them that the current, un-reviewed proposals are available. This will give everyone an opportunity to touch base with any of the applicants if they would like to get involved with a project before it goes to the PRS for review.

- ♦ August 1-17, 2007: Assembly Planning Committees will meet via conference call to review appropriate proposals. Any proposal that has indicated on the form that a specific ATS committee may want to become involved will be sent to the ATS committee chair and to the appropriate staff member. Committees are encouraged to work with appropriate ATS staff and review any proposals and to send recommendations to the applicant and to the PRS.

- ♦ September 4, 2007: Revised proposals and all reviews from Assemblies and Committees are due to ATS office. This includes any proposal that has revisions based on a review by an Assembly Planning Committee or an ATS Committee.
- ♦ Early October 2007: Program Review Sub-Committee (PRS) meeting
- ♦ Early November 2007: Program & Budget Committee (P&B) meeting. Recommendations from the PRS will be provided to the P&B Committee. At the discretion of the P&B Committee, specific projects will be added to the FY2007 budget as new items.
- ♦ December 2007: ATS Board reviews FY 2008 Budget
