Message From Assembly Chair Mark D. Eisner, MD, MPH

Welcome to the Spring newsletter from the Assembly on Environmental and Occupational Health. I look forward to seeing you all at the 2010 ATS International Conference in New Orleans, Lousiana on May 14-19, 2010. The conference promises to be filled with great science, fun social activities, and the fabulous food and culture of New Orleans. In particular, the EOH Program Committee has put together a phenomenal series of sessions, including postgraduate courses, poster sessions, and minisymposia, that will present the latest science focused on environmental and occupational health.

I wanted to share with you my two main initiatives that have been the focus of my first year as Chair of the EOH Assembly. The first initiative builds upon the work initiated by Dr. Kent Pinkerton during his tenure as EOH Assembly Chair - to enhance the recruitment of fellows and junior faculty into our assembly. I wanted to take the opportunity to thank the EOH Assembly leadership who are working so hard on behalf of all of us. Dr. Fernando Holguin (Chair) and Dr. Marc Schenker (Chair Elect) have been spearheading the Program Committee to ensure a terrific program at the ATS meeting. A key function of the Planning Committee's is to help develop ATS EOH Assembly Statements and Position Papers, which typically ensue from ATS-funded Assembly projects.

This was a challenging year for all the Assembly Planning Committees. *ATS suspended NEW projects for 2010.* However, we were fortunate that one outstanding new project that did not require funds in 2010 was approved and our high quality existing projects were renewed.

New Project

4th Jack Pepys Workshop on Work-Related Asthma (Chair – Susan Tarlo). No funds were requested for FY2010. The aim of this project is to convene a one day workshop in Toronto, immediately before the 2010

ATS annual meeting in New Orleans, to focus on prevention of work related asthma (funding secured from Ontario and Quebec Workers' Compensation Systems with further support possible from AllerGen, a Network of centres of excellence in allergy in Canada). ATS will endorse this workshop. A secondary aim to explore, with a subgroup of the invited participants, the aproach to developing a useful document as a Statement on Prevention of Work-related Asthma.

Renewed projects

Spirometry in the Occupational Setting (Project Chairs – Susan Tarlo and Carrie Redlich. This project will develop an ATS Statement of recommendations for PFTs in the occupational setting.

Work-Exacerbated Asthma (Project Chair - Paul Henneberger)

The goal of this ATS Project, supported by the ATS and the CDC / NIOSH, is to review and synthesize the literature on work-exacerbated asthma (WEA), identify research and clinical needs, and increase awareness of WEA. The statement is very far along.

Updating the 1996 ATS Statement: "Respiratory Protection Guidelines" (Project Chair – David Weissman). ATS issued guidelines on respiratory protection in 1996. The current project is necessary because, since then, much has changed. Regulations cited in the statement are now obsolete. Respiratory protection terminology and practices have changed. A new class of FDA-approved respirators for use in public emergencies, such as pandemic influenza, has been developed. This project will update the statement.

Respiratory Impairment and Disability (Project Chair - Phil Harber)

Assessing respiratory impairment, occupational respiratory disability, and occupational ability are significant from the clinical, public health, socioeconomic, and regulatory/legal perspectives. The ATS has previously addressed these areas in three statements.

In United States, the AMA Guidelines for the Assessment of Permanent Impairment ("The Guides") are widely used. While there have been periodic revisions of the Guides, the general approach has not changed in decades. The project will systematically examine the conceptual basis for assessing the impairment (loss of function), disability (the impact upon work/life activities), and residual ability.

Diagnosis and Management of Beryllium Sensitization and Chronic Beryllium Disease (Project Chair - John Balmes).

This goal of this project, jointly supported by the ATS, the U.S. Department of Energy (DOE), and the CDC / NIOSH, is to establish consensus among a panel of international experts regarding criteria for the diagnosis, clinical evaluation, management and prevention of beryllium sensitization (BeS) and chronic beryllium disease (CBD). The consensus findings and recommendations will be published as an ATS Policy statement.

Novel Risk Factors and the Global Burden of Non-smoking COPD (Project Chair – Mark Eisner). The goal of this project is to develop an ATS statement that will evaluate the contribution of non-traditional risk factors

(other than smoking) to the development of COPD, including environmental tobacco smoke, occupation, biomass fuel combustion, air pollution, and genetic and dietary factors. The statement should be published this year.

2) Standardizing Low Molecular Weight (LWM) Occupational Allergens (Project Chair - Adam Wisnewski). An ATS Workshop addressing theoretical and technical aspects regarding assays for LMW occupational allergens was held. A document summarizing the findings and recommendations of this workshop is being finalized.

The Planning Committee has also been reviewing current ATS EOH Statements (available at www.thoracic.org/sections/publications/statements/index.html) to determine which ones would benefit from updating or revising.

We are extremely fortunate that David Weissman has agreed to take over as Chair from Stephanie London who has served for the past two years. If you are interested in serving on the EOH Planning Committee, developing a new EOH Assembly Project, or revising any of the older ATS EOH Statements please contact David Weissman (dqw4@cdc.gov). Assembly Project applications are usually due mid-July.
