Message From the Assembly Chairperson Mary J. Morrell, Ph.D.

I am pleased to have this opportunity to update you on the activities of our Assembly. We have had a busy year with many exciting new developments. Our focus this year has been on widening participation, and on increasing our educational activities. We welcome Susmita Chowdhuri and Klar Yaggi who have taken on the role of Patient Education in our Assembly. Currently, the SRN patient information series is limited. Susmita and Harry plan to develop materials on basic topics such as 'Treatment of Sleep Apnea' and some pulmonary overlap syndromes e.g. Sleep Apnea and COPD; Sleep Apnea and Asthma; Obesity Hypoventilation. Followed by other specific important clinical topics such as: Sleep Apnea, Heart Disease and Stroke; Sleep Apnea and Hypertension; Sleep and Diabetes. The SRN Assembly also welcomes Susheel Patil and Malcolm Kohler as our new Web directors. They will take over the content of our webpage, including our successful Sleep Fragments feature. We now have an excellent collection of interesting traces and cases that receive many hits from the ATS membership and beyond. I know you will join me in a vote of thanks to Evelyn Schlenker and James Rowley who are stepping down as our Web Directors – they have done a great job. We welcome any comments on this or any other issues.

This year the International Conference will once again be preceded by its post graduate courses. We thank the Educational Committee and Atul Malhotra for their support in enabling us to programme one of these courses on sleep, including pediatric sleep medicine. The courses will provide added value to our trainee delegates travelling to the Conference. I urge you to tell your junior faculty about them, if you have not already done so.

The International Conference itself will be packed full of exciting symposia highlighting the latest basic translational and clinical research in the area of sleep and control of breathing. However, I am conscious that in programming more sleep sessions we may have created the perception that we have moved away from basic research. Moreover, that we do not embrace our links with control of breathing – this is not the case. One of the strengths of the ATS International Conference is the translational nature of our activities. The SRN Assembly is committed to this ethos and to supporting all our members in their research. We welcome any comments on this or any other issues.

Advocacy

The ATS is committed to the prevention and treatment of respiratory diseases through research, education, patient care and AD-VOCACY......

When I started my term as Assembly Chair one of the things I was least aware of is the tremendous amount of advocacy work the ATS undertakes on legislative as well as regulatory issues. The Washington Office is 'the hub of a nationwide Legislative Network that enables state and local ATS volunteers, members, and staff to participate in grassroots advocacy on public policy initiatives'. The SRN Assembly has been particularly busy this year campaigning on a number of important issues that affect our community.

Proposed Decision Memo for Sleep Testing for Obstructive Sleep Apnea (CAG-00405N): In January 2009 the ATS was invited to comment on the proposed decision memo for coverage of portable monitor sleep testing for the diagnosis of OSA (CAG-00405N). Dr Sam Kuna has been taking the lead on these issues on behalf of the SRN Assembly (you can read his reports on the 2007 MedCAC meeting and subsequent changes in the coverage for CPAP at http://

www.thoracic.org/sections/aboutats/assemblies/srn/news/pages/ medcac.html). Again we called on him to prepare a response on behalf of the SRN Assembly. This statement was reviewed and amended by members of the SRN Executive/ Planning Committees. It was then approved and endorsed by the ATS Executive and submitted to CMS on behalf of the ATS. The statement can be viewed on the SRN Assembly website. If you would like further details on any of these issues, please contact Sam or myself. Alternatively you may wish to contact the ATS staff (gewart@thoracic.org).

State of Washington (Medicaid) coverage of sleep devices: In January we were also informed that State of Washington was conducting an assessment of sleep apnea diagnosis and treatment (www hta hea wa goy). It was pro-

(www.hta.hca.wa.gov). It was proposed that all available evidence

would be reviewed to determine if the diagnosis and treatment of OSA was effective, and should continue to be paid for through the state Medicaid program. It was felt that other States would pay close attention to this review, and that the group could implement positive or negative changes based on their findings. The State of Washington was seeking clinical evidence that supported the need for the diagnosis and treatment of sleep apnea. Again I asked Dr Kuna to prepare a response on behalf of the SRN Assembly. After appropriate review by members of our Assembly it was endorsed by the ATS Executive and submitted on behalf of the ATS on the 16th January 2009. The statement can be viewed on the ATS website and again please contact either Sam or myself for further information.

The SRN Assembly is grateful to the ATS Executive Committee and Gary Ewart in the ATS Washington Office for working with us on the very tight deadlines for these documents;

especially as they were submitted in the midst of the inauguration celebrations!

ACGME Sleep Training Fellowships: This year we have also been lobbying in the area of Education. We all know that to keep our research and clinical practice thriving we need to attract top people into our community. However, there is a major concern that changes to the ACGME Training Program has seriously reduced the number of Pulmonary-oriented people taking up Sleep Fellowships. With this in mind Dr Atul Malhotra (SRN Assembly

Chair-Elect) has been working with the ATS Executive to put an alternative suggestion to the ACGME. Our aim is to present a tri society approach to the ACGME. He has formulated a letter which has been endorsed by the ATS/SRN Leadership, the ATS Education and Training Committees, the ACCP and Association of Pulmonary & Critical Care program directors. The proposal is now with the AASM. For more information on this issue please contact Atul or myself.

I wish to take this opportunity to thank all the North American mem-

bers of our Assembly for their help in guiding me through this aspect of my role as Assembly chair. Although these issues covered are mainly USA clinical policy, I believe the impact of these changes is worldwide, and something to which our Assembly must pay particular attention. It has been very rewarding to see the difference we have made on these issues.

Pediatric Sleep-Disordered Breathing Workshop Ann C. Halbower, M.D., Vice Chair, Health Policy Committee, ATS

Childhood sleep-disordered breathing (SDB) is associated with a myriad of health problems that underscore the need for early diagnosis and treatment. For example, children with SDB present with behavior problems, {Chervin, 2006 1886 / id; Huang, 2007 2044 /id}*, deficits of general intelligence, {Rhodes, 1995 1007 /id;Blunden, 2000 1003 / id}, learning and memory deficits, {Gozal, 2007 2060 /id} evidence of brain neuronal injury, {Halbower, 2006 1861 /id}, increased cardiovascular risk profiles, {Gozal, 2008 2045 /id}** and poor quality of life. {Baldassari, 2008 2050 /id}* The health care utilization rates of children with SDB far exceed those of normal children.{Tarasiuk, 2007 2126 /id}

There is evidence that the majority of the problems associated with childhood SDB improve with treatment. Treatment of pediatric SDB

has improved behavior{Li, 2006 2067 /id;Garetz, 2008 2068 /id} and even reversed diagnoses of Attention Deficit Disorder, a common overlap symptom of SDB.{Huang, 2007 2044 /id}* Cardiovascular risk profilesLi, 2008 2061 /id; Kheirandish-Gozal, 2006 2049 /id} and quality of life {Baldassari, 2008 2050 / id; Mitchell, 2007 2063 /id} Evidence suggests that treatment improves function and outcome in many domains, suggesting that early diagnosis and treatment should be the standard of care in order to protect children from brain or cardiovascular injury, until proven otherwise.

Despite these facts, childhood SDB is still an under-recognized disorder, with gaps in awareness of physicians, teachers, and parents. {Strocker, 2007 2066 /id;Tamay, 2006 2129 /id;Owens, 2001 2131 / id} Children with even moderate to

severe SDB continue to have delays in diagnosis because of a lack of awareness of the important symptoms by parents, and a lack of screening by primary care providers.

In April, 2006, the Institute of Medicine (IOM) of the National Academies released a report on the status of academic sleep research and sleep medicine in the United States. The report included recommendations to improve public awareness and strengthen the field of sleep medicine. The project was initiated and funded by the National Institutes of Health (NIH), the American Academy of Sleep Medicine, Sleep Research Society, and the National Sleep Foundation.

The ATS has accomplished two major directives for 2009 toward the goal of sleep disorder recognition: 1)

calling on Centers for Disease Control to implement additional policies and public health interventions to address the epidemic of sleep-related disorders in the U.S., and 2) a directive calling on NHLBI to continue investments in basic research to understand the impact that sleep and the circadian cycle has on the development of pulmonary and cardiovascular disease and other sleep-related illnesses.

Pediatric SDB requires specific labeling as a public health problem, with targeted education of multidisciplinary health practitioners and the community to increase early recognition and diagnosis.

On Saturday, May 16th a workshop will take place at ATS 2009 in San Diego entitled, "Pediatric Sleep-Disordered Breathing, an Unrecognized Public Health Problem". The purpose of this workshop is to provide a forum for discussion between experts in pediatric sleep medicine, epidemiology, and economics; members of sister societies, ATS assembly chairs, NIH, and members of ATS government relations, to influ-

ence policy in regards to the management of pediatric SDB.

The American Thoracic Society is in an ideal position to affect progress in research, partner with NIH to fund programs for community education, influence medical school curriculum, and with the help of sister societies, initiate a policy of early recognition, diagnosis, and treatment of pediatric SDB.

Message from the Program Chair James A. Rowley, M.D.

Seva Polotsky (Program Chair-elect) and I have put together what we believe is an exciting program for the 2009 ATS International Conference. The program will highlight the latest basic/translational research as well as the latest clinical advancements in our field.

We have 2 major symposia this year in the basic/translational track: Hypoxia and Hypercapnia in Sleep, and Ventilation in the Sleeping Obese

Patient. There are 2 major symposia that are primarily translational in nature: Sleep-Disordered Breathing Beyond Obesity and Metabolic Syndrome and Respiratory Disorders. Finally, we have an exciting clinical symposium, New Frontiers in the Management of Obstructive Sleep Apnea, that promises to highlight the future of OSA management.

In addition to our major symposia, we have an excellent research pro-

gram planned as well. The minisymposia, poster discussion and thematic poster sessions that will highlight research in control of breathing during sleep, intermittent hypoxia, upper airway pathophysiology, the interaction of cardiovascular disease and SDB, and clinical aspects of SDB.

- 1) Pediatric Sleep-Disordered Breathing: An Unrecognized Public Health Problem (PI: Ann Halbower). This project will increase awareness of sleep disordered breathing in children.
- 2) State-of-the-Art Update on Sleep Disorders (PI: Richard Schwab, Co-PI Atul Malhotra). This project will lay the groundwork for an ATS sponsored state-of-the-art course on sleep disorders independent of the ATS international meeting.

3) Sleep Apnea, Sleepiness and Driving Risk II (PI: Kingman Strohl). This project will examine driving risk in patients in patients with sleep apnea.
